IT'S THAT TIME OF YEAR

Without a doubt, Toys for Tots is one of the most popular charitable events the Lodge sponsors each year. Once again we will collect donations for this program run by the United States Marine Corps Reserve. Since 1947, it has distributed toys to children whose parents cannot afford to buy them anything for Christmas. For the past two years our Lodge has received the Marine Corp's Commandants Award for our outstanding contribution to the toy drive. Last year members donated more than \$5,000 in gifts and cash to Toys for Tots. Beginning September 30th, please drop of your donation at the clubhouse through early December. A collection box will be located in the lobby. Gifts should be new and unwrapped, preferably costing \$10 or more. Books are also welcomed (each child receives two gifts and three books count as one gift). Handmade toys are also acceptable. We want to thank our own "Santa Claus" and Esquire, Patrick Fitzpatrick, who oversees this worthy cause each year.



LODGE NEWS

Thank you to everyone who donated blood last month and helped make our first-in-a-long-time blood drive a success. We had 30 people show up and we plan on having the Red Cross back again next year. Special thanks go to member Renée Lauber, for organizing this event and being there all day to make sure everything went smoothly. Also we want to thank Trustee Don Geier who furnished snacks for the donors.

As we mentioned last month, we now have a new fall menu and hope you have tried it. Much thought went into it, taking into account food options members have said they wanted to see in both the dining room and bar. There was also an emphasis on reducing food waste and cost. We continue to have our fish fry special on Friday night and, due to popular demand, prime rib has returned on Saturday night.

We will continue to air all the Packer games and away Badger games in the bar. When this occurs on a day the clubhouse is normally closed (Sunday through Tuesday), we offer a limited bar menu. That said, we can only continue to do this if we have the support of the members, otherwise it's not financially feasible.

On October 1, State President Karl Hanke challenges all members to attend the Easter Seals Pancake Breakfast at [Camp Wawbeek](#), the State Major Project in Wisconsin Dells. He asks that everyone meet in the upper camp between 9:50 and 10 a.m. so we can walk in together. Please wear red! There will be group photos taken.

On Thursday, October 5 live music returns to the bar with the popular band Rusty Bumper. It will perform in the bar from 6-9 p.m.

Prior to the October 11 membership meeting, we will have our annual inspections by the Deputy District Grand Exalted Ruler. DDGER Kathy Hagen and her party will visit our Lodge to physically inspect the premises and interview the officers about policies and procedures. They will arrive at 4 p.m. and stay through the membership meeting. If you are at the Lodge that evening, please be sure to welcome them to Madison.

On Sunday, November 5 we will observe another annual event, the visit of the Wisconsin Elks Association President. This year we will welcome State President Karl Hanke of Wausau and other state officers. We'll observe the occasion with a special Packer's game day. The bar will open at 10 a.m., followed by a buffet brunch from 10:30-11:30 a.m. in the dining room. At 11:30 there will be a brief program with the game televised at noon. The cost of the buffet is a suggested \$10 donation. More details will be coming soon but please mark your calendar.

Also, in November we will host our annual Veterans Day Breakfast on Saturday, November 11. Look for more information soon.

MEMBERSHIP MATTERS

October 1 marks the beginning of the second half of the fiscal year. We currently have 760 members. Last year on October 1 we had 726 members. However, last year at this time we had 43 delinquent members as compared to 56 currently. (Members still delinquent by March 31, 2024, will be dropped.) We are still on track to end the fiscal year with a net gain, but it means continuing to propose new members each month and convincing those members who have not paid their dues for this year to do so.

In November the Secretary will notify members now eligible for Lifetime Membership (membership for at least 30 years in this Lodge or another Lodge). A Lifetime Member's dues are 50% of those assessed by our Lodge, plus those assessed by the Grand Lodge and state association. These candidates for Life Membership will be elected at the December membership meeting.

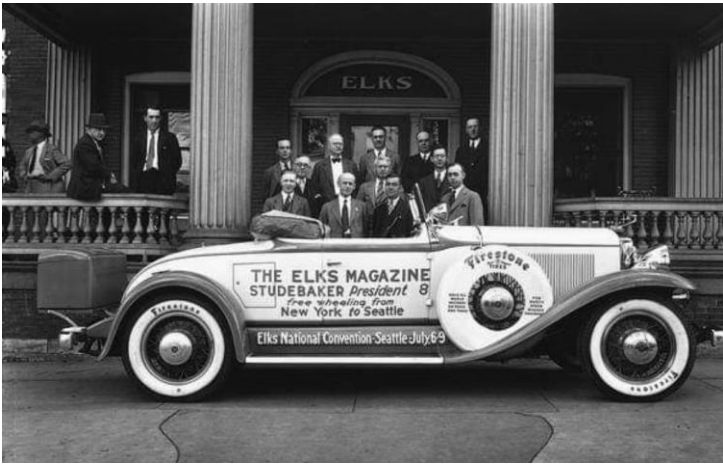

POSTCARD FROM THE PAST



From the Elks Magazine in 1931, a photo of a Studebaker "President 8" parked in front of the Elks Club at 120-124 Monona Avenue (now Martin Luther King, Jr., Blvd.). The car's crew is posing with local Lodge members who welcomed them to Madison. The car was on its way from Lodge #1 in New York to the national convention in Seattle.

GEORGE E. RAPP



George Edward Rapp was born on July 16, 1916, in Madison, Wisconsin, the son of George C. Rapp and Marie Schram. He graduated from Edgewood High School in 1934 and attended the University of Wisconsin where he was a member of Sigma Chi fraternity. George graduated from the UW law school in 1940. On May 29, 1941, he married Agnes Marie Strumeiter from Fifiield, Wisconsin. They had one child, a daughter Nancy.

In 1944 he was appointed an Assistant District Attorney for Dane County. Known for his prosecutorial skills in the courtroom, in 1953 President Dwight Eisenhower appointed him United State Attorney for the western district of Wisconsin.

Rapp was a lifetime member of the Elks and Exalted Ruler of Madison Lodge #410 from 1963 to 1964. Later in life he would transfer his membership to Baraboo Elks Lodge #688. While a member of the Baraboo Lodge, George was elected District Deputy Grand Exalted Ruler in 1973. He was an active supporter of the sports programs at Edgewood High School and served as a director of its Athletic Association.

On March 4, 1967, he married a second time to Dorothy Jane Gillespie. Until this second marriage, Rapp had resided his entire life in the house he was born in at 1135 Erin Street.

On May 15, 1997, Rapp was himself a victim of crime when he and his wife, both in their 80s, were robbed at gunpoint in their home in Fitchburg. He died the following year on February 7. Dorothy died on May 12, 2002 and is buried with George in Forest Hill Cemetery.
